

RENTAL CONDITIONS

1 - Payment Terms

The payment includes the hire of the vessel and its equipment, according to the "Inventory". The value includes a cleaning fee and mandatory insurance.

Additionally, a small deposit will be charged to cover damage to the vessel.

The vessel will be delivered ready for use and in perfect condition.

Payments must be:

- 50% on reservation
- 50% cash or check at time of shipment
- No credit or debit cards accepted

2 – Bail

A deposit of € 100, 00 must be held by the customer prior to shipment.

In case of loss or damage caused to the vessel and/or its equipment by the client, Ânima Durius will retain the value equivalent to its repair or replacement.

The deposit must be by cash or check and will be returned in full, in case of non existence of damage or defect caused by the customer on the boat, after returning to the base of Ânima Durius.

3 – Ânima Durius Duties

Ânima Durius is obliged to deliver the boat to the customer in perfect working condition, operating without any defect and with the water and fuel tanks filled.

Ânima Durius will endeavor to repair or replace any equipment that may suffer damage during the rental period, provided that advised as soon as the fault occurs.

4 – Customer Duties

Upon receipt of the vessel, the customer is responsible for all expenses related to docking, fuel, water and cleaning of the boat.

Any accident or injury involving the vessel, its possessions and equipment during the rental period should be reported immediately to Ânima Durius.

The customer must comply with all regulations and rules to keep the boat and its belongings in perfect condition, as well as navigate and operate the vessel in a responsible manner and in accordance with the rules of navigation.

The customer cannot rent a boat to a third party, participate in races, or make commercial use in advertising. Towing any other craft (kayaks, jet skis, surfboards, motorboats, sailboats, etc..), is forbidden as it is sailing after the sunset.

The customer cannot navigate or operate the vessel under the influence of alcohol or any illegal substances.

Pets are not allowed on board.

The use of barbecue, incense and candles it is forbidden, as well as smoking inside the cabin.

5 - Delivery of the boat to the customer

The customer will receive the vessel at the base of Ânima Durius in Foz do Távora, at the agreed date and time. During the delivery of the vessel, the client should carefully examine its conditions and of the equipment, according to the "Statement of Condition", dating and signing it.

Any possible complaint or dissatisfaction must be notified before starting the navigation. Defects detected by Ânima Durius at the time of delivery, as well as those likely to occur during the rent do not entitle the customer to ask for reductions or refunds.

When requested, the client or the person designated by him to be in charge of navigation should prove to be able to operate the vessel safely and in accordance with the rules of navigation.

If by the time of shipment the customer fails to enable valid and necessary documents for the navigation, Ânima Durius reserves the right not to deliver the vessel. In case of cancellation for this reason, the company shall not refund the reservation fee already paid.

6 - Return of the vessel to Ânima Durius

The customer is obligated to return the vessel to the base of Ânima Durius, in the time and date established. Ânima Durius should be informed by the customer 15 minutes prior to the arrival to Foz do Távora.

If, for any reason, the return cannot meet the date and time agreed, the client must inform Ânima Durius as soon as possible. Failure to comply with these rules without the

consent of Ânima Durius, implies the payment of a fee equivalent to the daily rent, for each day in delay.

The costs of fuel will be charged based on the missing liters in the tank.

The garbage on board should be wrapped in closed garbage bags, to be removed by the cleaning staff.

It is the client's responsibility to verify that all personal belongings of the crew are landed.

Based on the "Statement of Condition", signed at the time of delivery, a further inspection will be performed in the presence of the customer, to verify the good condition of the vessel and all its equipment.

7 - Insurance

The Compulsory Insurance covers the value of the vessel in case of total loss.

Includes further € 100.000,00 for liability; € 10.000,00 for own damage; € 20.000,00 for death or permanent disability and € 3.500,00 for treatment costs.

The value of the insurance fee is included in the rental price.

8 - Cancellation

A) By the customer

When a cancellation takes place, the return of the reservation fee will be made as follows:

90% of the fee for cancellations until 31 days from date of shipment.

80% of the fee for cancellations between 10 and 31 days from date of shipment.

There will be no return of the deposit for cancellations made less than 10 days from the date of shipment.

B) By Ânima Durius:

In case of unforeseeable circumstances or force majeure events preventing the departure of the vessel, Ânima Durius is entitled to cancel the lease by full refund of the deposit made or, when agreed, to fix a new date for hire, not allowing the customer the right to compensation of any other nature.
